

# Data Privacy Notice

## Data Controller Information

The operator of the site and related software is:

Proworx Digital Ltd. (registered office: Budapest 1026 Harangvirág str. 5. II/3., Hungary; company registration number: 01 09 334879; hereinafter referred to as “Proworx Digital” or the “Company”) processes your personal data in accordance with this Data Privacy Notice, effective from **1 September 2025**.

The data controller is responsible for the data processing processes occurring on the website and in connection with the software.

## Scope of Processed Personal Data

We do not process any personal data suitable for direct identification. Only technical data necessary for the operation of the system are processed.

- We do not require registration or login.
- We do not maintain a newsletter mailing list.
- We do not use marketing or analytical tools.
- Visitors can use the website and the software completely anonymously.

## Automatically Collected Data

To ensure the operation and security of the website, the server may record technical data, such as:

- the IP address from which the website is accessed,
- the time of the visit,
- the type and version of the browser,
- the subpages viewed and the time spent on those pages.

These data are used solely to maintain system security, are not used to identify visitors personally, and are stored exclusively in logs provided by the hosting service provider.

Legal basis: GDPR Article 6(1)(f) – legitimate interest (ensuring the operation of the system).

## Cookies and Similar Technologies

The website may use the minimum necessary cookies required for operation (e.g. session cookies), which do not store personal data.

We do not use:

- analytical cookies (e.g. Google Analytics),
- marketing or tracking cookies,
- third-party advertising tools.
- List and purpose of cookies:

Strictly necessary cookies: required for the technical operation of the website, such as page loading and functionality.

Non-essential cookies: none.

## Data Retention Period

The retention period of technical data generated during the operation of the website (e.g. server log files, IP address, visit time, browser type) is a maximum of 30 days.

After this period, the data controller automatically deletes or anonymizes the data, unless their retention is required by law or justified for the investigation of a security incident.

## Data Transfers and Data Processors

We do not process any personal data suitable for direct identification, only technical data necessary for system operation.

The hosting service provider and the server administrator may use technical log data to maintain system operation and security.
